3. The ACT (Section 51(1) (b))

- 3.1 The ACT grants a requester access to records of a private body, if the record is required for the exercise or protection of any rights. If a public body lodges a request, the public body must be acting in the public interest.
- 3.2 Requests in terms of the ACT shall be made in accordance with the prescribed procedures, at the rates provided. The forms and tariff are dealt with in paragraphs 6 and 7 of the Act.
- 3.3 Requesters are referred to the Guide in terms of Section 10 which has been compiled by the South African Human Rights Commission, which will contain information for the purposes of exercising Constitutional Rights. The Guide is available from the SAHRC.

6. Form of Request to Access Information

To facilitate the processing of your request for information, kindly:

- 6.2 Address your request to the Head of the Company/Information Officer.
- 6.3 Provide sufficient details to enable the Company or Entity to identify:
 - a) The record(s) requested;
 - b) The requester (and if an agent is lodging the request, proof of capacity);
 - c) The form of access required;
 - i) The postal address or fax number of the requester in the Republic;
 - ii) If the requester wishes to be informed of the decision in any manner (in addition to written) the manner and particulars thereof;

- d) The right which the requester is seeking to exercise or protect with an explanation of the reason the record is required to exercise or protect the right.

7. Fees Payable

The fees for reproduction of a record as referred to in section 52(3) are as follows -

7.1 for every photocopy of an A4 size page or part thereof	R1.10
7.2 for every printed copy of an A4-size page or part thereof	R0.75
7.3 for a copy of a compact disc	R70.00
7.4 for a transcript of visual images for an A4 size page or	R40.00
7.5 for a copy of visual images	R60.00
7.6 for a transcript of an audio record, for an A4-size page or	R20.00
7.7 for a copy of an audio record	R30.00

- The request fee payable by a requester, other than a personal requester is R50, 00.
- If the preparation of the record requested requires more than the prescribed hours (six), a deposit shall be paid (of not more than one third of the access fee which would be payable if the request were granted)
- A requestor is required to pay the prescribed fees (R50.00) before a request will be processed and records may be withheld until the fee has been paid.
